On-Going

1. <u>Contract</u> – Still no official word from DSHS regarding the contract. As a result, no planning or discussions can occur between HOTRAC and CATRAC regarding it. However, EMTF work continues to move forward with deployability and asset locations.

<u>Updates</u>

- 1. TXEMTF Meetings
 - **a.** <u>Ambus</u> Conference Call Only shared information regarding activities and maintenance issues. Nothing pertinent to report.
 - **b.** Operations Did not meet.
 - i. <u>Standing Orders</u> The existing standing orders will be distributed to some of the group supervisors and EMTF Charge Nurses for their input.
 - **c. IDRU** Did not meet.
 - **d.** <u>Coordinators</u> Discussed staffing at the TDEM Conference. In addition, started a discussion about the MMU typing/equipment par levels and the costs of upkeep. This will be discussed at future meetings. Some discussion points included;
 - Standing orders say an MMU should be able to do a procedure, but not all have the required equipment. Should they obtain one for their cache (which changes the typing) or should an additional EMTF respond to supply the equipment.
 - Is the amount of equipment in the MMU cache too much? This affects the cost of replacing stuff that has expired.
